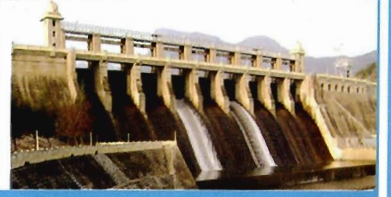

கடந்த 27.11.2019 அன்று 98 உதவிசெயற்பொறியாளர்களுக்கு செயற்பொறியாளர்களாக தற்காலிக பதவி உயர்வு (Temporary Promotion) அளிக்கப்பட்டது. தமிழ்நாடு பணியாளர் தேர்வாணையம் (TNPSC) மூலம் தேர்ந்தெடுக்கப்பட்ட உதவிப் பொறியாளர்களின் முதுநிலை (Seniority) சம்பந்தமாக கடந்த மாதம் உயர்நீதிமன்றம் அளித்த தீர்ப்பை அமுல்படுத்த மிகுந்த கால தாமதம் ஆகும் என்பதால், துறையில் நிறைய செயற்பொறியாளர் காலி பணியிடங்கள் உள்ளதால் மழைக்காலங்களில் வெள்ளத்தடுப்பு போன்ற அவசர பணிகளை கவனிக்க உடனடியாக செயற்பொறியாளர் பதவிகள் தேவை என்பதால் ஏற்கனவே உள்ள முதுநிலைப்படி (Pre Revised Seniority) தற்காலிக பதவி உயர்வு அளிக்கப்பட்டது.

In the letter read above, the Engineer-in-Chief, Water Resources Department and Chief Engineer (General), Public Works Department, Chennai has stated that the Sarabanga Basin Division, Namakkal is under the control of Upper Cauvery Basin Circle, Water Resources Department, Trichy Region and its office is located in the District Collector's office campus, Namakkal. He has also stated that the following four Sub Divisions are under its control:-

- (i) Sarabanga Basin Sub Division, Salem
- (ii) Sarabanga Basin Sub Division, Attur
- (iii) Sarabanga Basin Sub Division, Namakkal
- (iv) Sarabanga Basin Sub Division, Rasipuram

2. The Engineer-in-Chief, Water Resources Department and Chief Engineer (General), Public Works Department, Chennai has also stated that the following Sub Basin and Reservoirs are located in Salem and Namakkal Districts:-

(1) Thirumanimuthar Sub Basin

There are 14 Anicuts and 14 lakes having ayacut of 3943.22 ha., in Thirumanimuthar Sub Basin under Sarabanga Basin Division in Salem District.

There are 27 Anicuts and 52 lakes having ayacut of 2893.71 ha., in Thirumanimuthar Sub Basin under Sarabanga Basin Division in Namakkal District.

(2) Sarabanga Sub Basin

There are 11 Anicuts and 17 lakes having ayacut of 3630.00 ha., in Sarabanga River under Sarabanga Basin Division in Salem District.

(3) Upper Vellar Sub Basin

There are 75 Anicuts and 35 lakes having ayacut of 5340.42 ha., in Vasishta River under Sarabanga Basin Division in Salem District.



(4) Swetha Sub Basin

There are 33 Anicuts and 16 lakes having ayacut of 2387.76 ha., in Swetha River under Sarabanga Basin Division in Salem District.

(5) Karaipottanar Sub Basin

There are 54 Anicuts and 28 lakes having ayacut of 4155.87 ha., in Karaipottanar River under Sarabanga Basin Division in Namakkal District.

Anaimaduvu Reservoir

- 4) Construction of a Check Dam across a odai in Kottaimedu Village of Omalur Taluk in Salem District

Estimate Amount Rs.1.20 Crore.

- 5) Construction of a bridge across Raja Vaikkal at mile 2/3 in Anangoor village of Paramathi Velur taluk in Namakkal District.

Estimate Amount Rs.75.00 Lakhs.

- 6) Rehabilitation and Improvements to Sarabanga River at LS 42.80 Km to LS 43.30Km in Edappadi Town of Edappadi taluk in Salem District.

- 7) Rehabilitation and Improvements to Sarabanga River at LS 43.30Km to LS 43.80Km in Edappadi town of Edappadi taluk in Salem District.

- 8) Construction of a bridge across Mettur West bank canal at LS 11.390 Km in Mettur Taluk of Salem District.

4. ORDER:

The following notification shall be published in the **Tamil Nadu Government Gazettee:-**

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendments to the Fundamental Rules.

2. The Amendments hereby made shall be deemed to have into force on the 1st January, 2016.

AMENDMENTS.

In the said Fundamental Rules, in rule 22-B

(1) for the paragraph commencing with the expression "Notwithstanding anything contained in these rules," and ending with the expression "Pay in the Pay band shall be stepped up to the minimum in the higher post", the following paragraph shall be substituted, namely:-

"Notwithstanding anything contained in these rules, where a Government servant holding a post in a substantive or officiating capacity, is promoted or appointed in a substantive or officiating capacity, to another post carrying duties and responsibilities of greater importance than those attached to the post held by him, his initial pay in the level of the higher post in the pay matrix shall be fixed by granting one increment in pay in the level of the lower post and he shall be placed at a cell equal to pay so arrived at in the level of the higher post, and if no such cell is available in the level of the higher post to which he is promoted, the initial pay shall be fixed at next higher cell in the level of the higher post. However, if the pay so arrived at in the level in the lower post after granting one increment is lower than the minimum pay or the first cell in the level of the higher post, the initial pay shall be fixed at minimum pay or the first cell of the level of higher post.";



- (2) In the third proviso, -
- (a) In clause (i), for the expression "pay band", the expression "level in the pay matrix" shall be substituted;
- (b) for clause (ii), the following clause shall be substituted, namely:-
- "(ii) for fixation of pay on the date of promotion or appointment to the higher post, initially to draw the next higher pay cell available in the level of the higher post to the pay cell in the level of the lower post and for re-fixation of pay under this rule on the date of accrual of next increment in the lower post, by granting two increments, one accrued on account of annual increment and second on account of promotion, in the level of lower post and his pay shall be fixed at a pay cell equal to the pay so arrived at, in the level of the higher post, in the pay matrix and if no such cell is available in the level of the higher post to which he is promoted, the initial pay shall be fixed at next higher cell in the level of the higher post. Such option shall be exercised within a period of one month from the date of promotion or appointment. The option once exercised shall be final. If no such option is exercised within the said period of one month, the pay shall be fixed in the manner as provided in clause (i) above. If the pay is fixed in the manner as provided in this clause, his next increment shall be allowed on completion of the required qualifying period of one year with effect from the date of re-fixation of pay".;
- (3) in the fourth proviso, for the expression "pay band and grade pay" the expression "level in the pay matrix", shall be substituted.;
- (4) in rulings 2(ii) and (6), for the expression "pay band and grade pay" the expression "level in the pay matrix", shall be substituted.

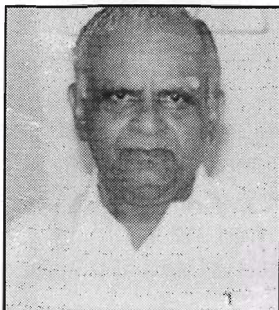
