கடந்த பல ஆண்டுகளாக இளம்பொறியாளர் / உதவிப்பொறியாளர்களுக்கு உதவிசெயற்பொறியாளர் பதவி உயர்வு வழங்காமல் துறையில் 65% உதவிசெயற்பொறியாளர் பதவிகள் காலியாக உள்ளன. புதிதாக பொறுப்பேற்றுள்ள மாண்புமிகு அமைச்சர் பெருமக்களும், மரியாதைக்குரிய பொதுப்பணித்துறை கூடுதல் தலைமைச் செயலாளர் அவர்களும் விரைந்து உதவிசெயற்பொறியாளர் பதவி உயர்வு வழங்க முயற்சிகள் மேற்கொண்டு வருகிறார்கள். விரைவில் உதவிசெயற்பொறியாளர் பதவி உயர்வு வழங்கப்படும் என்று நம்புகிறோம்.



பொதுப்பணித்துறையை இரண்டாக பிரிப்பது சம்பந்தமாக அனைத்து சங்கங்களின் கருத்துக்களை கேட்டறிவதற்காக கடந்த 02.06.2021 அன்று அரசு சிறப்பு செயலாளர் (Special Secretary) தலைமையில் கூட்டம் நடைபெற்றது.

பொதுப்பணித்துறையை இரண்டாக பிரிப்பதற்காக முதன்முதலாக 08.11.2006 அன்று அரசாணை பிறப்பிக்கப்பட்டது. அதன்படி 2007 ஆம் ஆண்டுதான் உதவிப் பொறியாளர்கள் தமிழ்நாடு பணியாளர் தேர்வாணையம் (TNPSC) மூலமாக கட்டிடத்துறை, நீர்வள ஆதாரத்துறை என்று தனித்தனியாக தேர்வு செய்யப்பட்டார்கள். எனவே 2007 ஆம் ஆண்டுக்கு முன்பு வரை தேர்வு செய்யப்பட்ட ஊட்டுப்பதவி உதவிப் பொறியாளர்கள் (By transfer Assistant Engineers), இளம்பொறியாளர்களை பொதுவான முதுநிலையில் வைத்து பதவி உயர்வு அளிக்க வேண்டும் என்பதை நமது சங்கத்தின் பிரதான கோரிக்கையாக வைத்தோம். பாசீலிப்பார்கள் என்று நம்புகிறோம்.

வாழ்க தமிழ்நாடு பொறியியல் சங்கம் வளர்க பொறியாளர்களின் சங்க உணர்வு தேச நலன் காப்போம்.

### ORDER:-

#### **NOTIFICATION**

WHEREAS on considering the recommendations of the expert team of Doctors and Public Health Specialists and based on the directives of Government of India, Ministry of Home Affairs, day-to-day increase in Covid - 19 positive cases, Statewide complete lockdown was enforced throughout the State with effect from 4.00 A.M. of 10.05.2021 to 4.00 A.M. of 24.05.2021, in order to control the spread of COVID - 19. Thereafter, the complete lockdown was extended upto 06.00 A.M. on 31.05.2021.



2. Now, therefore the Government in accordance with the Press Release dated 28.05.2021, issue the following order under Disaster Management Act, 2005 extending complete lockdown upto 06.00 A.M. on 07.06.2021.

The following activities alone shall be permitted during the complete lockdown from 06.00 A.M. on 31.05.2021 till 06.00 A.M. on 07.06.2021.

- i. Medical shops, Indigenous Medical Shops, Veterinary Pharmacies and Pet feed shops shall be permitted.
- ii. Supply of Milk, Water and distribution of Newspapers shall be permitted.
- iii. Sale of Vegetable and Fruits through mobile vehicle shall continue in all the districts in co-ordination with respective departments. Provision shops shall be permitted to sell provisions through mobile vehicles / carts in the residential areas after obtaining permission from the respective local bodies and to provide home delivery of provisions in respect of the orders received over phone / online. These sales will be permitted during the period 07.00 A.M. to 06.00 P.M.
- iv. Public Distribution Shops shall be permitted to operate from 08.00 A.M. to 12.00 Noon.
- v. Petrol, Diesel Bunks and LPG supply related activities shall be permitted.
- vi. Parcel food only shall be permitted in the hotels, restaurants and bakeries from 6.00 A.M to 10.00 A.M., 12.00 Noon to 3.00 P.M. and 6.00 P.M. to 9.00 P.M. All E-commerce food delivery entities shall be permitted to operate only during this time schedule.
- vii. Other E-commerce services shall be permitted from 08.00 A.M. to 06.00 P.M.
- viii. Wholesale Vegetable, Fruit and Flower Markets (Koyambedu and Wholesale Markets in Districts) shall be permitted to function. Retail Shops in Wholesale Markets shall not be permitted.
- ix. Railways, Airport, Sea Port operations shall be permitted.
- x. All activities related to basic essential infrastructure sectors like, Power, Water Supply, Sanitation, Telecommunication, Postal Services etc., shall be permitted.
- xi. Print and Electronic Media shall function.
- xii. Government Offices dealing with essential services like Secretariat, Health and Family Welfare, Revenue Administration, Police, Home Guard, Fire and Reduce Services, Prisons, District Administration, District Industries Center, Government Press, Food and Co-operatives, Electricity, Water Supply, Local Bodies, Forest Offices, Treasuries, Social Welfare Department, PWD Maintenance Wing, Power Generation, Transmission & Distribution Units, Agriculture, Animal Husbandry etc., and other departments dealing with natural calamities and their associated support services shall function with required staff.



- xiii. Banks, Insurance Institutions, RBI regulated financial markets, entities like NPCI, CCIL, Payment system operators, Clearing Houses and stand alone primary dealers shall be permitted with 1/3<sup>rd</sup> staff. ATMs and related banking services shall be permitted.
- xiv. SEBI and capital and debt market services as notified by the Securities and Exchange Board of India (SEBI) shall be permitted to function with 1/3<sup>rd</sup> staff.
- xv. Medical related services including Blood Bank shall be permitted.
- xvi. Visa Facilitation Centres for emergency travel purpose shall be permitted to function with minimum staff who may be permitted to travel with ID cards issued by the respective organizations.
- xvii. Homes for children / differently abled / mentally challenged / senior citizens / destitute / women / widow and related transportation shall be permitted with e-registration.
- xviii. Staff working in observation homes, after care homes and places of safety for juveniles shall be permitted with ID Card or e-registration.
- xix. Agriculture and related activities including transportation of agriculture produce and agro inputs shall be permitted.
- xx. Operations of animal husbandry farms including poultry farms & hatcheries and livestock farming activities and animal health related activities shall be permitted.
- xxi. Cargo handling including Cold storage and warehousing services at ports, airports, railway station, container Depots and associated services shall be permitted.
- xxii. All Goods vehicles and transporation of essential commodities shall be permitted. Movement, loading / unloading of goods / cargo (inter and intra State) shall be permitted.
- xxiii. Transportation to and from place of residence to Airports / Railway Station shall be permitted with e-registration details for their travel, travel tickets and ID proof.
- xxiv. Continuous Process Industries and Industries manufacturing essential commodities as listed in G.O. Ms.No. 348, Revenue and Disaster Management (DM IV), Department, Dated: 20.04.2021 are permitted to function adhering to the SOPs and other safety measures issued already. In addition, Export units, units which have export commitments or export orders and their vendor units providing inputs to such industries shall be permitted to function with 50% of workers in all the districts except Coimbatore, Tiruppur, Salem, Karur, Erode, Namakkal, Trichirapalli and Madurai Districts. The movement of Staff / Workers in these Industries shall be permitted to travel only in four wheelers



- like Buses, Vans, Tempos and Cars arrangement by respective industries with e-registration.
- xxv. Industries which have been permitted to operate shall initiate immediate action to vaccinate all their employees within a month's time.
- xxvi. Hotels / Lodges designated as Covid Care Hospitals / Covid Care Centres and Hotels / Lodges meant for housing health care professionals shall be permitted to function. Workers of such Hotels / Lodges shall be permitted with ID Cards issued by the respective hospitals authority which have en gaged the hotels / lodges.
- xxvii. Ongoing in-situ construction works shall be permitted with the workers staying in the construction premises.
- xxviii. Volunteers, Caregivers providing food and other services for persons with special needs, differently abled, senior citizens shall be permitted to travel with e-registration.
- xxix. Inter State and Inter District travel in case of individuals, shall be permitted for medical emergencies and funeral / last rites with e-registration.
- xxx. Intra district travel shall be permitted for medical emergencies and funeral / last rites without e-registration.
- xxxi. In order to monitor the passengers coming by air and train from foreign countries and other states, e-registration (https://eregister.tnega,org) shall continue to be in force.
- 3. The Government also orders that no activities shall be permitted in the Containment Zones.
- 4. The Commissioner, Greater Chennai Corporation / District Collectors concerned shall take all necessary measures for the strict enforcement of National Directives for Covid 19 management viz., wearing of face masks, hand hygiene and social distancing, spitting in public places, screening & hygiene, frequent sanitization of entire workplace etc., and adherence of the Standard Operating Procedures issued for the permitted activities. The Commissioner, Grater Chennai Corporation / District Collectors concerned shall initiate appropriate action for imposing fines on persons violating the National Directives.
- 5. Any person violating these measures will be laible to be proceeded against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.

#### **ABSTRACT**

**MEDICAL AID** – New Health Insurance Scheme, 2021 – Provision of Health Care Assistance to the Employees of Government Departments, State Public Sector Undertakings, Statutory Boards, Local Bodies, State Government Universities etc., and their eligible family members through the United India Insurance Company Limited, Chennai - Implementation - Orders – Issued.

#### READ:

- 1. G.O.Ms.No.202, Finance (Salaries) Department, dated: 30-06-2016.
- 2. G.O.Ms.No.279, Finance (Salaries) Department, dated: 24-06-2020.
- 3. G.O.Ms.No.57, Finance (Salaries) Department, dated: 26-02-2021.

#### ORDER:

In the Government Order first read above, orders were issued for implementation of New Health Insurance Scheme, 2016 to provide health care assistance on a CASHLESS basis for employees of Government departments etc., and their eligible family members with a provision to avail assistance up to the limit of Rs.4.00 lakh and in respect of specified illness the enhanced limit was up to Rs.7.50 lakh for a block period of 4 years from 01-07-2016 to 30-06-2020 for the accredited treatments/surgeries in the hospitals approved by the United India Insurance Company Limited.

- 2. In the Government Order second read above, orders were issued to extend the New Health Insurance Scheme, 2016 for employees of the Government departments etc., and their eligible family members beyond 30-06-2020, for a period of another one year from 01-07-2020 to 30-06-2021, with assistance capped at Rs.4.00 lakh for families of all insured employees and at Rs.7.50 lakh for specified illnesses, as per existing terms and conditions of agreement made with the United India Insurance Company Limited.
- 3. The Government has examined the need for continuation of New Health Insurance Scheme for the Employees of Government Departments, State Public Sector Undertakings, Statutory Boards, Local Bodies, State Government Universities etc., and their eligible family members and decided to continue the same after selection of a suitable Public Sector Health Insurance Company through National Competitive Bidding as in the case of New Health Insurance Scheme, 2016.



Accordingly, in the Government Order third read above, orders have been issued for the implementation of the New Health Insurance Scheme, 2021.

- 4. Based on the Government orders issued in reference third read above, the Notice Inviting Tender, dated 26-02-2021 has been issued. The Tender Scrutinizing Committee, i.e. the Principal Secretary to Government [Expenditure], Finance (Salaries) Department, the Commissioner of Treasuries and Accounts and the Director of Medical and Rural Health Services, after following due procedure as per the Tamil Nadu Transparency in Tenders Act, 1998 and the Tamil Nadu Transparency in Tenders Rules, 2000, submitted its report on 18-06-2021 to select the United India Insurance Company Limited, Chennai for implementing the New Health Insurance Scheme, 2021 for the Employees of Government Departments, State Public Sector Undertakings, Statutory Boards, Local Bodies, State Government Universities etc., and their eligible family members.
- 5. The recommendation of the Tender Scrutinising Committee has been considered and the tender has been awarded to the United India Insurance Company Limited, Chennai. The said Company shall execute an agreement with the Government of Tamil Nadu for the implementation of the New Health Insurance Scheme, 2021.
  - 6. The Government after careful consideration directs that:-
- (1) "New Health Insurance Scheme, 2021 for Employees of Government Departments, State Public Sector Undertakings, Statutory Boards, Local Bodies, State Government Universities etc., and their eligible family members be implemented through the United India Insurance Company Limited, Chennai as set out in "The Guidelines for implementation of the New Health Insurance Scheme, 2021 for Employees of Government Departments, State Public Sector Undertakings, Statutory Boards, Local Bodies, State Government Universities etc., and their eligible family members appended to this order in Annexure -A;
- (2) The Commissioner of Treasuries and Accounts shall be the administrator of the New Health Insurance Scheme, 2021;
- (3)The enrolment under New Health Insurance Scheme, 2021 shall be compulsory, which is a separate scheme for all the employees irrespective of the fact that their spouse is a Central Government Employee covered under Central Government Health Insurance Scheme (CGHS) as detailed in para 3 of Annexure-A to this order;
- (4) The employees of Government Departments, State Public Sector Undertakings, Statutory Boards, Local Bodies, State Government Universities etc., and their eligible family members covered under the scheme shall avail assistance upto the limit of Rupees Five Lakh in a block of four years commencing from 01-07-2021 to 30-06-2025 as a CASHLESS model for the approved treatments / surgeries listed in the Annexure-I to this order, in the hospitals approved by the United India Insurance Company / Third Party Administrator and listed in the Annexure-II to this order;



- (a) However, the assistance shall be upto Rupees Ten Lakh for Specified illrnesses listed out in Annexure I-A to this order;
- (b) The upper limit of medical assistance for cataract surgery shall be Rs.30,000/- per eye. In respect of Hysterectomy (uterus removal surgery) the upper limit of medical assistance shall be Rs.50,000/-.
- (c) The overall limit of assistance, in any case shall not exceed Rupees Ten Lakh for a family in a block of four years under this scheme.
- (d) The medical treatment taken by the employees of Government Departments, Local Bodies, State Public Sector Undertakings, Statutory Boards and State Government Universities etc., and their eligible family members in Non-Network hospital under Non-Emergency situation shall also be covered on reimburs ement basis. However, since the quality of treatment and facilities provided in a Nonnetwork Hospital is not known and the employee is consciously choosing to avail treatment in such hospital, the quantum of reimbursement in such cases shall be restricted to 75% of the package rate of similar procedure in the lowest grade Network hospital.
- (e) This scheme covers 203 approved treatments and surgeries with 1,169 empanelled hospitals.
- (f) The scheme is also extended to the parents of the employee, in case of unmarried employee until the employee gets married, in case of a divorced employee not having children until such employee gets re-married.
- (g) The payment of annual premium shall be regulated as per the terms and conditions of the agreement between the Government of Tamil Nadu and the United India Insurance Company Limited, Chennai;
- (5) The annual premium payable by the Government to the United India Insurance Company, Chennai shall be at the rate of **Rs.3,240/-** [plus Goods and Services Tax as applicable from time to time] per Employee, per annum for the block period of four years from 01-07-2021 to 30-06-2025;
- (6) A sum of Rs.5/- per month shall be contributed separately by all the employees along with the monthly Health Insurance premium for creating a Corpus Fund (non-lapsable), with annual accrual of about Rs.5.60 crore for meeting higher expenses in respect of rare illness and exceptional circumstances, extending the total benefit upto Rs.20.00 lakh. These cases shall be decided by the High Level Committee already formed in G.O.Ms.No.202, Finance (Salaries) Department, dated 30-06-2016.
- (7) The annual premium initially paid by the Government shall be recovered from the employee at the rate of Rs.300/- per month [Rs.295/- Subscription for NHIS + Rs.5/- contribution for corpus fund] by deduction in monthly salary from the month of July, 2021.
- (8) Eventhough the legal spouse is covered under the term 'Employee', the total assistance to the Family will be limited to Rupees Five Lakh only in respect of diseases covered in Annexure-I and Rupees Ten Lakh only per family for specified



illnesses listed in **Annexure-IA**. The overall limit of assistance shall not exceed Rupees Ten Lakh only per family in a block of four years.

- (9) In case both the employee and spouse are State Government employees, the employee's contribution shall be recovered from only one of the employees i.e. from the younger of the two.
- (10) The employees appointed on (a) Consolidated Pay / Fixed Pay / Honorarium, (b) Daily Wage, (c) Contract basis, (d) Re-employment, (e) Temporary basis under Rule 10 (a) (i) of the Tamil Nadu State and Subordinate Services through Employment Exchange and (f) Outsourcing are not covered under this Scheme.
- 7. The Government also direct that the monthly subscription of Rs.295/- towards New Health Insurance Scheme, 2021 for the Employees of Government Departments shall be credited to the following Revenue Receipt Heads of Account:

The Government vide G.O. 1st cited, had ordered that the salary and other establishment related payments in respect of the Public Works Department be drawn only by bills through Treasuries under Electronic Clearance System with effect from 01.04.2012 instead of existing Letter of Credit System, so as to enable the compilation of "Data Base for Government Employees and Pensioners" as recommended by the 13th Finance Commission.

Accordingly, drawing officers were nominated vide reference 2<sup>nd</sup> cited for presenting the bills on salary and other establishment related payment to the respective PAO / District Treasury / Sub Treasury with effect from 01.04.2012. Among others, the respective Assistant Executive Engineers were nominated as Drawing Officers as far as the Salary and Establishment related payments of Sub Division offices concerned.

Further in G.O. 3<sup>rd</sup> cited, the Government had ordered that the Letter of Credit System for Public Works (PWD-Buildings / WRD) Forest Department etc., be discontinued and the transactions of these departments shall be made only be presenting bills in the PAO / District Treasury / Sub Treasury concerned under existing Electronic Clearance System with effect from 01.04.2016.

Accordingly, the Divisional Officers / Executive Engineers concerned of WRD Divisions were nominated as Drawing Officers vide reference 4<sup>th</sup> cited, duly specifying the name of the PAO / District Treasury / Sub Treasury to which they are attached for are presenting all kinds of bills and drawal of funds.

This system of presenting all kinds of bills and drawal of funds by the Executive Engineers concerned to the respective PAO / District Treasury / Sub Treasury has been in practice in WRD since 01.04.2016. In the meantime the Government have rolled out the IFHRMS through the State in all Departments, in which the details up



to Sub Divisional level have been mapped in, as far as the WRD in concern ed. All the bills including eatablishment related payment, salary and work bills are presented to the PAO / District Treasury / Sub Treasury through online mode under IFHRMS, from October 2020 onwards. The Assistant Executive Engineers concerned of WRD are presenting the bills on salary and establishment related payment through online mode under IFHRMS with the uique user id and password assigned to them.

Now there have been representations from several quarters of the department as to permit the Assistant Executive Engineers concerned to present all kinds of work bills to the respective PAO / District Treasury / Sub Treasury in view of the implementation of IFHRMS. In as much as Assistant Executive Engineers concerned of WRD have already been presenting the salary and establishment related bills to the respective PAO / District treasury / Sub Treasury and considering the present workloads of Division / Sub Division offices, the possibilities for permitting the Assistant Executive Engineers concerned of WRD for presenting all kinds of work have been explored in detail.

After careful considering of the above and that the Government had ordered in reference 3<sup>rd</sup> cited that the Heads of Departments shall nominate Drawing Officers, it is directed that the Assistant Executive Engineers concerned of WRD, who had been nominated as Drawing Officers vide reference 2<sup>nd</sup> cited for presenting the salary and establishment related bills to the specified PAO / District Treasury / Sub Treasury to which they are attached, shall also present are kinds of work bills including refund of work deposits and drawal of funds.

The Divisional Officers / Executive Engineers shall reallocate the appropriation in respect of works to the Assistant Executive Engineers concerned under their control.

All the procedure outlined in the reference 3<sup>rd</sup> and 4<sup>th</sup> cited, shall be scrupulously followed by the Divisional Officers and Drawing Officers.

As regards the deposit works, new deposit accounts were already opened in the PAOs/DTOs/STOs/ in respect of the Division concerned. Now that the Assistant Executive Engineers concerned shall be presenting the work bills as Drawing Officers to the PAOs/DTOs/STOs concerned, new deposit account for Class I, Class II, Class IV & Class V be opened in respect of Division concerned in the PAO/DT/ST to which the Assistant Executive Engineers are attached as drawing officers. In respect of the Class III Deposits the existing system of practice shall be continued.

As regards the GST, the Operational Guidelines for remittance of TDS issued under reference 5<sup>th</sup> & 6<sup>th</sup> cited shall be continued. The Nodal Officer nominated thereon shall fill the necessary returns as per the procedure in vogue.

Consequent on formation of two separate Department viz., Water Resources Department and Public Works Department, there is a need to delegate the powers in respect of establishment matters of Public Works Department, Buildings Organisation to the Engineer-in-Chief (Buildings) & Chief Engineer (Buildings), Chennai Region, Public Works Department, Chepauk, Chennai.
  - 4. The Government, after careful consideration, issue the following orders:-
- (i) A separate GENERAL UNIT shall be formed in the office of the Engineer-in-Chief (Buildings) & Chief Engineer (Buildings), Chennai Region, Public Works Department, Chepauk, Chennai to deal with all establishment matters of Public Works Department viz., Recruitment, Preparation of Estimate of vacancy, Panel proposals, Promotions, Transfer and Postings, Pay fixation, Disciplinary matters, Retirement, Pension proposals, as per the provisions of existing Statutory Acts and Rules.



- (ii) The above said General Unit shall function under the control of the Engineer-in-Chief (Buildings) & Chief Engineer (Buildings), Chennai Region, Public Works Department, Chepauk, Chennai.

#### **ABSTRACT**

**PENSION/FAMILY PENSION** – Furnishing of Life Certificate, Non-employment Certificate and Non-remarriage/Non-marriage Certificate by the Pensioners/Family Pensioners including Digital Life Certificate thro' Jeevan Pramaan Portal – Exemption from Annual Mustering Process for the year 2021 as a special case due to Covid-19 - Orders – Issued.

- 2. G.O.Ms.No.103, Finance (Pension) Department, dated 31-03-2015.

- From the Principal Secretary/Commissioner of Treasuries and Accounts, Chennai-35, Rc.No.015716/2021/E2, dated 12-05-2021

#### ORDER:

In the Government Order first read above, orders were issued that State Government Pensioners including Family Pensioners shall furnish Life Certificate, Non-Employment Certificate and Non-remarriage/Non-marriage Certificate at any time during the months of April, May and June every year to the Pension Disbursing Officer concerned after duly getting it attested by the authority mentioned in the said Government Order. If the Pensioners / Family Pensioners do not furnish/



produce the said Certificates on or before 30th June, the Pension Disbursing Officer concerned shall call for annual mustering of the Pensioners / Family Pensioners during the month of July every year. If the Pensioners / Family Pensioners neither produce the said certificates nor appear for annual mustering, the Pension Disbursing Officer concerned shall stop the payment of pension / family pension with effect from the month of August and the payment of pension / family pension will resume only on production of the said certificates or the Pensioner / Family Pensioner shall appear in person before the Pension Disbursing Officer concerned.

- 2. In the Government Order second read above, orders were issued that Pensioners including Family Pensioners shall furnish additional information along with Life Certificate. In the Government Order third read above, the Government in partial modification of the orders issued in the Government Orders first and second read above, directed that the State Government Pensioners/Family Pensioners be allowed to give their Life Certificate at any time during the months of July, August and September every year for annual mustering instead of April, May and June to the Pension Disbursing Officer concerned. If any pensioner including family pensioner fails to do so, the Pension Disbursing Authority shall call for the personal appearance in October and pension/family pension will be stopped from November onwards for those pensioners including family Pensioners who neither appear directly for mustering nor furnish life certificate.
- 3. In the reference fourth read above, orders were issued exempting the Annual Mustering Process for the year 2020 as a special case due to COVID-19 by relaxing S.R 67(a)(1) and S.R 71(a)(1) of Tamil Nadu Treasury Rule 16.
- 4. Some Individual Pensioners and the Pensioners Association have now requested to dispense the Annual Mustering process for the year 2021, considering the COVID situation now prevailing citing the exemption given in the year 2020.
- 5. In the reference fifth read above, the Principal Secretary/ Commissioner of Treasuries and Accounts has informed the Government that in the prevailing COVID-19 pandemic situation (Second Wave), if the mustering is conducted, there is possibility of spreading the Corona disease among the aged Pensioners/Family Pensioners who are already suffering from age related ailments and are highly vulnerable to infections. To avoid overcrowding and resultant infection to the aged Pensioners/Family Pensioners, he has requested the Government to issue necessary orders either for
- (a) Exemption of Annual Mustering process of Pensioners/Family Pensioners for the year 2021 (or)
- (b) Obtaining Life Certificate generated through the Jeevan Pramaan Portal during the period from July 2021 to December 2021.



- 6. Though generation of digital Life Certificate, by the Pensioners cam be done thro' the Jeevan Pramaan Portal, the old aged Pensioners/Family Pensioners are in the practice of Annual Mustering and that it may not be appropriate to insist the old age Pensioners/Family Pensioners to approach the e-Sevai Common Service Centre during the COVID pandemic period for furnishing digital Life Certificate considering the fact that Pensioners/Family Pensioners, being senior citizens, fall among the most vulnerable category with respect to risk of exposure to COVID.
- 7. The Government after careful consideration of the above facts and the current pandemic situation accept the request of Pensioners Association as well as the proposal of Principal Secretary/Commissioner of Treasuries and Accounts and accord temporary exemption of the Annual Mustering Process including furnishing of Life Certificate/Digital Life Certificate through Jeevan Pramaan Portal for the year 2021 as a special case by relaxing S.R 67(a)(1) and S.R 71(a)(1) of Tamil Nadu Treasury Rule 16.

2. In rule 28, after the first proviso to sub-rule (1), the following proviso shall be inserted, namely:-

#### (II) Nomination of SC / ST Members in DPC

The Government have issued orders in the Government Order third read above nominating a Schedule Castes / Scheduled Tribes Officer as a member of Departmental Promotion Committee for the posts to which rule of reservation shall apply, so as to ensure their representation as per rules. The procedure now being followed for the posts to be placed before the Departmental Promotion Committee headed by Chairman / Member of Tamil Nadu Public Service Commission, shall also be followed for the posts to which rule of reservation apply and placed before the Departmental Promotion Committee headed by Secretary to Government of the administrative department concerned.

#### (III) Venue of the meeting:

The meeting shall take place in the administrative department concerned in Secretariat.

#### (IV) Meeting Procedure:

- (a) All matters relating to convening of the meetings shall be dealt with by the concerned administrative department of Secretariat.
- (b) Action shall be taken in advance to finalize the estimate of vacancies by the administrative department of the Secretariat / Head of Departments as the case may be, two months prior to the crucial date.
- (c) The administrative department concerned shall prepare notes on proposals for preparing the list of eligible candidates for the various services relating to the respective department in accordance with the concerned service rules and circulate them of other Members and the Chairman of the Departmental Promotion Committee in advance. The proposals shall be strictly confidential.
- (d) The original of the service records and the personal files of the eligible candidates shall be made available at the time of the meeting.
- (e) The recommendation regarding eligibility shall be recorded in the proforma annexed to this order according to the consensus arrived at the time of meeting and signed by the Chairman / Members of the Departmental Promotion Committee. The minutes so communicated shall be treated as final and there shall be no further consultation with the Departmental Promotion Committee on the issue.



- (f) In any case, where the views of the Member / Nominee of the committee differ from the Member / Nominee of the Personnel and Administrative Reforms Department, then all the members shall record their views in the sectional notes. The administrative department concerned may follow the procedure indicated in the Government order first read above, if necessary.
- (g) All selections shall have to be made in accordance with the provisions of Special Rules concerned, Tamil Nadu Government Servants (Conditions of Service) Act, 2016 and Government orders and instructions in force.


