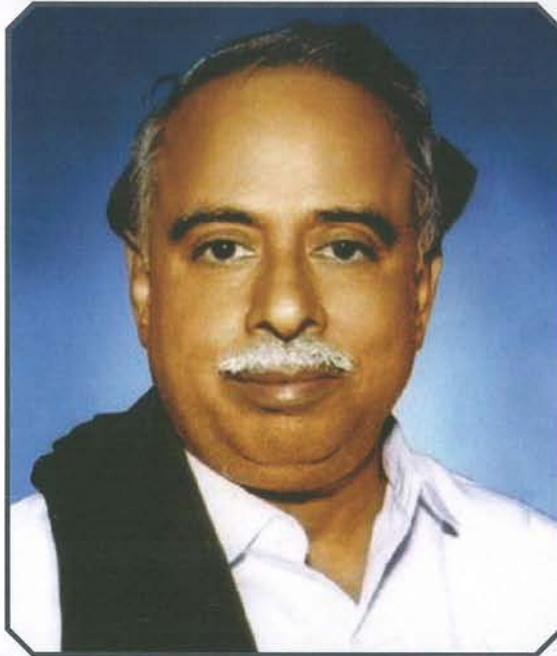

மாண்புமிகு முன்னாள் முதல்வர் முத்தமிழ் அறிஞர் டாக்டர் கலைஞர் அவர்களால் இடப்பட்ட அரசாணை எண்.1 பொ.ப.து நாள்: 02.01.1990ஐ நீக்கக்கோரி பொறியாளர் சங்கம் தொடுத்த வழக்கு உச்சநீதிமன்றத்தில் தள்ளுபடி செய்யப்பட்டது. மேற்கண்ட அரசாணையின்படி பணிமாற்றல் (By Transfer) மூலம் உதவிப்பொறியாளர் பதவி பெற்று இந்த உதவிசெயற்பொறியாளர் பதவி உயர்வு பட்டியலில் இடம் பெற போகும் 189 உதவிப்பொறியாளர்களுக்கு எதிராக சில தனி நபர்களால் நான்கு வழக்குகள் தொடுக்கப்பட்டு 2017 ஆம் ஆண்டு Statusquo order வழங்கப்பட்டுள்ளது. இது மொத்தமாக உதவிசெயற்பொறியாளர் பதவி உயர்வுக்கான Statusquo ஆணை ஆகும். இந்த Statusquo ஆணையை நீக்கி விட்டுதான் பதவி உயர்வு வழங்க வேண்டும் என்று முடிவெடுக்கப்பட்டுள்ளதாக தெரிய வருகிறது. அதன்படி Statusquo ஆணையை நீக்க பணிகள் நடைபெற்று வருவதாக தெரிய வருகிறது.

இந்த அத்தனை குழப்பங்களுக்கும் சில தலைமைப் பொறியாளர்களின் தவறான நடவடிக்கைகள்தான் காரணம்.

ORDER:

In the Government Order first read above, orders have been issued for approval of estimate of vacancy for the post of Executive Engineer (Civil) in Tamil Nadu Engineering Service, Branch-I, Public Works for the year 2021-2022 as 63 numbers.

2. In compliance of the Orders of the Hon'ble Supreme Court of India second read above, orders have been issued in the Government Orders third and fourth read above, revising the combined temporary lists of Assistant Engineers / Junior Engineers fit for promotion / appointment for the post of Assistant Executive Engineers approved for the year 2010-2011 and 2010-2011 (Supplementary list).

3. Consequent on the revision ordered in the post of Assistant Executive Engineer, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, in his letters sixth read above has sent proposal for approval of the



combined temporary list of Assistant Executive Engineers fit for promotion as Executive Engineers for the year 2021-2022 in Public Works Department and Water Resources Department.

4. In the Government order fifth read above, guidelines have been issued for the vertical separation of the Department into Public Works Department and Water Resources Department. In the said Government Order, among others, it has been ordered that all promotions / appointments from the year 2021-2022 has to be made by the respective Engineer-in-Chief of Public Works Department & Water Resources Department by formulating separate seniority lists.

5. In exercise of the powers conferred under Section 58 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016, the Governor of Tamil Nadu hereby relaxes Explanation III under Section 7 (1) of the said Act so as to approve the combined temporary list of Assistant Executive Engineers fit for promotion as Executive Engineers consisting of 63 numbers for the year 2021-2022 in Public Works Department and Water Resources Department.

6. Accordingly, the Government approve the combined temporary list of the following Assistant Executive Engineers in Category 4 in Branch I - Public Works of the Tamil Nadu Engineering Service selected for appointment by promotion as Executive Engineers in Category 3 of the said Branch of the said Service for the year 2021-2022 consisting of 63 numbers in Public Works Department and Water Resources Department, by relaxing paragraph 9 (c) of the Government Order fifth read above, in the order of seniority indicated below:-

ORDER:

In the Government Order first read above, among others, orders have been issued for the functioning of Water Resources Department and Public Works Department as two separate departments.

2. In the Government Order second read above, order have been issued for dividing Public Works Department, Building Organization into 3 regions and on the works allotted to the Regional Chief Engineers.

3. In the Government Order third read above, among others, the subject relating to Water Resources Department has been allocated to the Hon'ble Minister for water Resources and the subject relating to Public Works Department has been allocated to the Hon'ble Minister for Public Works.

4. In the Government Order fourth read above, amendments have been issued to the Tamil Nadu Government Business Rules, 1978 wherein the subjects relating to "Water Resources" which have been already existed under the heading "Public Works Department" have been omitted and those subjects have been inserted under the heading "Water Resources Department", separately.

5. In the Government Order fifth read above, orders have been issued for formation of a separate General Unit in the office of the Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chepauk, Chennai to deal with all establishment matters of Public Works Department.



6. In the Government Order sixth read above, orders have been issued stipulating guidelines for the vertical separation of the Department into Public Works Department and Water resources Department.

7. The Engineer-in-Chief (Buildings) & Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai in his letter seventh read above has requested orders of the Government on the following Amendments to the G.O. sixth read above:-

8. The Government after careful consideration, decided to accept the proposal of the Engineer-in-Chief (Building) and Chief Engineer (Building), Chennai Region, Public Works Department, Chennai and hereby issue the following amendments to the Government Order sixth read above:-

- (i) In the existing Paragraph 8, in Sl.No.1 Chief Engineer Post, the Total Number under the item "Sanctioned Staff Strength as per change in ratio" shall be modified as 20 instead of 19.
- (ii) In the existing Paragraph 8, in Sl.No.2 Superintending Engineer Post, the Total Number in respect of Public Works Department under the item "Sanctioned Staff Strength as per change in ratio" Shall be modified as 17 instead of 16 by adding one new post of Superintending Engineer which is created for a new Region at Coimbatore by re-organisation of Chennai and Tiruchirappalli Regions of Public Works Department.

(v) In the Paragraph 9(H) Quality Control Divisions, the existing sentence in sub para viz., "Villupuram, Salem and Tirunelveli be relocated to **Chennai, Madurai and Coimbatore** respectively"

shall be substituted with the following sentence;

"Villupuram, Salem and Tirunelveli be relocated to **Chennai, Coimbatore and Madurai** respectively".

The Hon'ble Chief Minister has made the following announcement on the floor of the Legislative Assembly under Rule 110 of LAS Rules on 07-09-2021:-

2. As per the Government order first read above, the Government employees, their spouse and dependent children upto 25 years of age are entitled to avail medical assistance for the treatments taken upto a maximum of Rs.5.00 lakhs and in respect of specified illness upto Rs.10.00 lakhs under the NHIS 2021. The subscription made to the scheme by employee is Rs.300/- p.m. **(Rs.295/- subscription for NHIS + Rs.5/- contribution for corpus fund)** for a block period of 4 years from 01.07.2021 to 30.06.2025.

3. Based on the announcement made by the Hon'ble Chief Minister on the floor of the Legislative Assembly under Rule 110 of LAS Rules on 07-09-2021, to extend medical assistance to the dependent children of Government employees without any age restrictions, the United India Insurance Company Limited which is implementing New Health Insurance Scheme, 2021 was requested to quote the



additional premium to cover the dependent children without any age limit under the Scheme and also create a help desk for hassle free treatment of employees. The Senior Divisional Manager, United India Insurance Company Limited has furnished the coverage of Dependents Children of the Government Employees under New Health Insurance Scheme 2021 subject to fulfillment of following conditions:-

- (i) Dependent Children is unemployed and unmarried.
- (ii) Pursuing higher studies and dependent on employee,
- (iii) Divorced female child without any children and dependent on the employee.
- (iv) Mentally disable children.

Further, based on the proposal of United India Insurance Company Limited, orders have been issued in the reference third read above among others notifying the details of Nodal Officers in help desk stationed in Top 50 hospitals for the benefit of all the employees covered under the New Health Insurance Scheme 2021.

4. The United India Insurance Company Limited in its letter dated 02.12.2021, considering the long standing relations with the Government, quoted a nominal premium of **Rs.20/- + GST per family per annum** to cover the dependent children of Government employees without age restriction from the date of receipt of the additional premium. The definition of dependent children would include the following in addition to what has been stated in the Government Order first read above.

- (i) Unemployed children.
- (ii) Children pursuing higher studies.
- (iii) Unmarried / legally divorced daughters who are dependent on the employee.
- (iv) Mentally handicapped children.
- (v) Declaration on the dependency of the child would be furnished by the concerned employee at the time of treatment / claim.

5. The Government after careful consideration of the proposal of the United India Insurance Company Limited, have decided to accept the additional premium of Rs.20/- + GST per family per annum quoted by United India Insurance Company Limited borne by Government to cover the dependent children of Government employees without age limit under the coverage New Health Insurance Scheme, 2021 for Employees of the Government departments with the conditions mentioned in **para 4** above. Accordingly, administrative sanction is accorded for a sum of Rs. 1.86 crore. (Rupees one crore and eighty six lakh) + **GST** per annum for a block period of 4 years commencing from 2021-2025 for additional coverage under New Health Insurance, Scheme, 2021 for employees of the Government department. However, for the balance first year period of New Health Insurance Scheme, 2021 financial sanction towards payment of additional premium is accorded for **Rs. 1,09,74,000/-** (Rupees one crore nine lakh and seventy four thousand only) (i.e., Rs.93,00,000/- + GST @ 18% Rs. 16,74,000/-) during the current financial year 2021-2022.

However, the above expenditure shall be brought to the notice of the Legislative Assembly to specific inclusion in the Supplementary Estimates for the year 2021-2022. In the Government Order first read above, orders were issued sanctioning revised rate of Dearness Allowance to State Government employees as detailed below:-

2. In the Government Order second read above, the Government has decided to adopt the decision of the Government of India for State Government employees, teachers and pensioners / Family Pensioners for freezing the Dearness Allowances at current rates till July, 2021 in view of crisis arising out of COVID-19.

3. Government of India in its Office Memorandum third and fourth read above has enhanced the Dearness Allowance payable to its employees from the existing rate of 17% to 28% and 28% to 31% respectively with effect from 1st July 2021.

4. Hon'ble Chief Minister has made announcement under Rule 110 of the Legislative Assembly that Dearness Allowance shall be given to the State Government Employees with effect from 01.01.2022. Accordingly, the Government sanction the revised rate of Dearness Allowance by enhancing 14% as indicated below:

5. The enhanced rate of Dearness Allowance payable under these orders shall be paid in cash with effect from 01-01-2022. Dearness Allowance for the period from 01-01-2020 to 31-12-2021 shall be paid at the rates of 17% continuously.

6. The Payment of Dearness Allowance for the month of January, 2022 shall be drawn and disbursed by existing cashless mode of Electronic Clearance System (ECS). While working out the revised Dearness Allowance, fraction of a rupee shall be rounded off to next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

7. The Government also direct that the revised Dearness Allowance sanctioned above shall be admissible to full time employees who are at present getting Dearness Allowance and paid from contingencies at fixed monthly rates. The revised rates of Dearness Allowance sanctioned in this order shall not be admissible to part time employees.

8. The revised Dearness Allowance sanctioned in this order shall also apply to the teaching and non-teaching staff working in aided educational institutions, employees under local bodies, employees governed by the University Grants Commission/All India Council for Technical Education scales of pay, the Teachers/Physical Education Directors/Librarians in Government and Aided Polytechnics and Special Diploma Institutions, Village Assistants in Revenue Department, Noon Meal Organisers, Child Welfare Organisers, Anganwadi Workers, Cooks, Helpers, Panchayat Secretaries/Clerks in Village Panchayat under Rural Development and Panchayat Raj Department and other employees drawing pay in the prescribed Level of Pay in the Pay Matrix.



9. The expenditure shall be debited to the detailed head of account "303. Dearness Allowance" under the relevant minor, sub-major and major heads of account.

10. The Treasury Officers / Pay and Accounts Officers shall make payment of the revised Dearness Allowance when bills are presented without waiting for the authorization from the Principal Accountant General (A&E), Tamil Nadu, Chennai-18.
