கோவிட் 19 போன்ற சில காரணங்களுக்காக கடந்த சில மாதங்களாக "பொறியியல் கதிர்" வெளியிட இயலவில்லை. அதற்காக எங்கள் வருத்தத்தை தெரிவித்துக் கொள்கிறோம்.

ஊதியக்குறைப்பு சம்பந்தமான வழக்கில் உச்சநீதிமன்றம் அளித்த தீர்ப்பின் அடிப்படையில் ஓய்வு பெற்ற டெல்லி உயர்நீதிமன்ற நீதியரசர் மாண்புமிகு த.முருகேசன் அவர்கள் தலைமையில் அமைக்கப்பட்ட குழு, தங்கள் அறிக்கையை கடந்த 05.09.2020 அன்று மாண்புமிகு துணை முதல்வர் அவர்களிடமும் 07.09.2020 அன்று மாண்புமிகு தமிழக முதல்வர் அவர்களிடமும் சமர்ப்பித்தது. இந்த அறிக்கை தற்போது அரசின் பரிசீலனையில் உள்ளது. இது சம்பந்தமான அரசாணைகள் விரைவில் வழங்கப்படலாம் என தெரிகிறது.

உதவிசெயற்பொறியாளர் பதவி உயர்வில் காலி பணியிட எண்ணிக்கை 492 எண்ணிக்கைக்கு அரசால் ஒப்புதல் அளிக்கப்பட்டுள்ளது.

ஊட்டுப்பதவியில் இருந்து வந்த உதவிப் பொறியாளர்கள் 75%ல் இடம் பெறக்கூடாது என்று சிலரால் தொடுக்கப்பட்ட வழக்கில் 2017 ஏப்ரல் மாதம் வழங்கப்பட்ட Status quo ஆணை இதுவரை நீக்கப்படவில்லை. இரண்டு முறை வழக்கு விசாரணை முடிந்து தீர்ப்பு வழங்கும் நிலையில் எதிர் பாராமல் தள்ளி போய்விட்டது.

வழக்கு விசாரணை தாமதமாவதால் Status quo ஆணையை நீக்க இரண்டு முறை, மீண்டும் இரு நீதிபதிகள் அடங்கிய அமா்வில் Modification Petition போட்டோம். ஆனால் Status quo ஆணையை நீக்க வில்லை. மாறாக முறையே 3 மாதத்தில் வழக்கை முடிக்க வேண்டும், 1 மாதத்தில் வழக்கை முடிக்க வேண்டும் என்று தீா்ப்பு வழங்கினாா்கள்.



தற்போது அரசால் மீண்டும் ஒருமுறை Status quo ஆணையை நீக்க Modification Petition போடப்பட்டுள்ளது. வழக்கு விசாரணையை எதிர்நோக்கியுள்ளோம். விரைவில் மேற்கண்ட வழக்கு விசாரணைக்கு வரும் என்று எதிர்பார்க்கிறோம்.

இது வரை பொதுப்பணித்துறை வரலாற்றில் இல்லாத அளவிற்கு மொத்தம் 758 உதவிசெயற்பொறியாளர் பணியிடங்களில் 492 உதவிசெயற்பொறியாளர் பணியிடங்களில் 292 உதவிசெயற்பொறியாளர் பணியிடங்கள் காலியாக உள்ளன. அதிகாரத்தில் உள்ளவர்கள் இதை உணர வேண்டும்.

வாழ்க தமிழ்நாடு பொறியியல் சங்கம் வளர்க பொறியாளர்களின் சங்க உணர்வு தேச நலன் காப்போம்.

இத்துடன் இந்த மடலை நிறைவு செய்கிறேன். மீண்டும் அடுத்த மடலில் சந்திப்போம். நன்றி.

The Government in the Para 1 (iv) of the letter 13th cited, have issued clarifications regarding the date of redesignating those Junior Engineers who have acquired the qualification of B.E., degree in Engineering as Assistant Engineers.

2. The Government in Para 1 (iv) have clarified as follows



It was instructed to take suitable action for redesignating the Junior Engineers who acquire B.E. degree as Assistant Engineers by taking into account the date of publication of result, as instructed in Government letter 3rd cited.

- 3. In view of the above said clarifications received from the Government, the orders already issued vide this office proceedings 7th to 11th cited, ordering the commencement of probation of those redesignated Assistant Engineers from the date of proceedings in which such redesignation has been ordered is hereby cancelled and revised orders issued as follows.
- 4. The date of commencement of probation of the redesignated Assistant Engineers as in Annexure I enclosed, is ordered to be commenced from the date of publication of results as detailed in column 8 of Annexure I. However, the date of commencement of probation in respect of those redesignated Assistant Engineers who had acquired the qualification of B.E., degree, during the period of probation in the post of Junior Engineer be commenced only after completion of probation in the post of Junior Engineer in Tamil Nadu Engineering Subordinate Service, as already ordered in G.O. 2nd cited and as detailed in column 8 of Annexure I enclosed.
- 5. The issue of revised orders of commencement of probation to the redesignated Assistant Engineers as in Para 4 above, is ordered without any entitlement to seniority in the Assistant Engineer post in Tamil Nadu Engineering Service, as direct by the Hon'ble Apex Court in its order dated. 27.11.2013 in the case relating to Thiru. B.Thirumal Vs Ananda Sivakumar, (Civil Appeals No's 10660-10662 of 2013 arising out of S.L.P (C) Nos 31761-31763 of 2009) but only for the purpose of financial benefits like pay fixation, movement to Selection grade / Special grade etc.
- 6. In accordance to Rule 7(a) of the Special Rules of the Tamil Nadu Engineering Service, the redesignated Assistant Engineers are deemed to have been placed on probation from the revised date of commencement of probation (as detailed in Col. 8 of Annexure I) for a total period of two years on duty within a continuous period of three years.
- The redesignated Assistant Engineers are eligible for drawl of arrears, if any, on account of this order.

ADVANCE INCREMENT – Sanction of advance increment to Government Servants for acquiring higher qualification and for passing Department Tests – Dispensation / Cancellation of the scheme of sanction of advance increment in all departments – Orders – Issued.

ORDER:

In the reference first read above, the Government have introduced the scheme of sanction of one advance increment for passing the Account Test Examinations, to the non-gazetted Government servants in the Ministerial Service. Subsequently, in the Government Order second read above, based on the recommendation of Tamil Nadu second pay commission, the erstwhile Public Works Department (i.e. before bifurcation), had issued orders sanctioning / granting advance increments to the Assistant Engineers / Executive Engineers / Divisional Engineers of Public Work and Highways and Rural Works Departments for acquiring PG/Ph.d in Engineering degree. In Government Order third read above, orders were issued



sanctioning two advance increments for those who acquire Post Graduate degree of Master of Management Sciences from recognized institutions. This was then extended to MBA holders also in the Government Order fourth read above.

- 2. Pursuant to the above orders, similar orders were also issued by various other departments like Agriculture Department, Animal Husbandry & Veterinary Sciences Department, Health and Family Welfare Department, Education Department, Labour and Employment Department, Rural Development Department etc for sanctioning advance increments to certain category of staff of those Departments for acquiring Post Graduate / Ph.d degrees in their respective subjects (These orders are made applicable to only certain category of posts mentioned in those orders and not for all category of posts in those Departments).
- 3. In the Government Order fifth read above, this department has issued a consolidated order for sanction of lumpsum grant (instead of advance increments) for acquiring some of the specialised courses in PG / Ph.D / MBA etc in the following Departments viz Agriculture Department, Agricultural Engineering, Diary Development Department, Animal Husbandry Department, Health and Family Welfare Department, Home Department, Personnel and Administrative Reforms Department subject to fulfillment of certain conditions stipulated therein. Later, the above scheme of lumpsum grant was again replaced with sanction of advance increments in the Government Order sixth read above. In continuation of the above orders and to make more clarity and to avoid misinterpretations, orders have been issued stipulating some conditions for sanction of advance increment in the Government Order eighth read above.
- 4. In the mean time, Government have reviewed the scheme of sanction of advance increment for acquiring MBA degree and taken a policy decision to dispense the scheme of sanction of advance increments for acquiring MBA degree, with effect from the date of issue order in the Government Order nineth read above. Subsequently, the Pay Grievance Redressal Committee constituted for the purpose of examining the anomalies arose due to the implementation of Tamil Nadu Revised Scales of Pay Rules 2009, has observed among others that in the present scenario where most of the recruits are degree holders and even have Post Graduation / professional qualification and in such a situation, the higher start of pay is no longer warranted and therefore recommended to dispense the higher start of pay to the Junior Assistants, Typists and Record Clerks for possession of Degree / S.S.L.C. qualification respectively. The Finance department has also accepted the above recommendation of the committee and issued orders in the Government order tenth read above, dispensing the higher start of pay granted to the Junior Assistants / Typist / Record Clerks for degree qualification / SSLC qualification to the incumbents recruited in future, with a view to avoid pay anomaly between Junior Assistants and the directly recruited Assistants and also considering the fact that the persons now recruited are Degree / Post Graduate / Professional Degree holders.



- 5. In continuation of the above review orders, Government, further reviewed the scheme of sanction of advance increment including sanction of advance increment for passing Account test for Sub-ordinate Officers part-1, taking into account of the following aspects:-
- a) During the period of introduction of above scheme, qualified persons are rarely identified for Government Posts. But, in present days, highly qualified persons including many professionals (Doctors and Engineers) are entering into Government Service through the concerned recruiting agencies for Group A and B Posts and even for Group C posts like Assistants / Junior Assistants / Typists etc. to do clerical jobs.
- b) Educational Institutions / Colleges are increased numerously and the qualified candidates are also increased multifold.
- c) Various recruiting agencies are selecting qualified persons suitable for the various posts in Government Service after conducting the tests / examinations at various stages.
- d) Qualified persons are available in all the fields to fill up the higher promotional posts in order to discharge duty of the post efficiently.
- e) If a Government Servants needs promotion / appointment to a higher post which carries higher qualification then it is the responsibility of the Government Servant to qualify himself / herself for promotion / appointment to that higher post.
- f) In several Departments, the higher qualified employees as well as regular qualified employees are discharging the same duty of the post concerned in routine manner only.
- g) Many departments are sanctioning the advance increments against the main conditions No.(ii) and (iv) stipulated in the Government Order eighth read above.
- h) Advance increments for passing Account test for Subordinates Officers Part I has been given to the Ministerial staff viz Assistants / Junior Assistants / Typists / Steno Typist etc. The syllabus covered in the above Department test has already been covered in the Foundational Training given by Bhavanisagar Training institute and all these Junior Assistants / Typists / Assistants are passing one paper in the said Foundational Training and passing this paper is mandatory for them for declaration of probation / consideration of promotion. Inasmuch as they acquired the knowledge of Fundamental Rules, Pension Rules, Tamil Nadu Financial Code / Tamil Nadu Treasury Code etc in the departmental Training itself, sanctioning the advance increments for passing the same subject in another form of test viz Account Test for Subordinate Officer Part I is unwarranted.
- i) Many anomalies arose due to the sanction of advance increments between seniors and juniors.



- 6. For the foregoing reasons, the Government have taken a decision to cancel / dispense with the scheme of sanction of advance increment for acquiring higher qualification and for passing Account Test for Sub-ordinate Officers Part-1, as per ruling (3) & (4)under FR 31-A and also to cancel the orders issued in Government orders fifth to eighth read above. Accordingly, the Government issue the following directions:-
- i. As a policy decision, the scheme of sanction of advance increment for acquiring higher qualification in all departments and all orders issued by all departments for sanction of advance increment for possessing higher qualification, as a whole, be cancelled / dispensed with immediate effect.
- ii. The orders issued in the Government Orders fifth to eighth read above be cancelled with immediate effect.
- iii. The sanction of the advance increment for passing Account Test for Subordinate Officers – Part-1, as per ruling (3) & (4) under FR 31-A be dispensed with immediate effect.
- iv. The advance increment for acquiring higher qualification already granted to Government Servants need not be effected any recovery
- v. All the departments of Secretariat / Head of the Departments are requested to take up a review on this issue with reference to the special / adhoc rules of the posts (entry to higher level) of the department concerned and to prescribe higher qualification to the posts wherever necessarily required, so as to improve the services of the department concerned.
- vi. The cases of Government servants who acquired higher qualification prior to issue of this general order, and not sanctioned with advance increments be examined separately as per the previous orders issued, if any, by the administrative department concerned and with reference to the posts specified in that order and if he is otherwise qualified, then the advance increment may be sanctioned by the administrative department concerned after obtaining concurrence of Finance department. If no previous orders were issued by any of the department concerned, then they are not eligible for sanction of any advance increments for passing higher qualification irrespective of the post held / degree acquired.
- vii. No fresh / further proposals will be entertained by Personnel and Administrative Reforms Department on this issue, in future.
- 7. Necessary amendments to Fundamental Rules will be issued separately with reference to para 6(iii) above.
- 8. This order issues with the concurrence of Finance (CMPC) Department, vide its U.O.No. 18808/CMPC/2019, dated 31.10.2019.

The Government have decided to increase the age of superannuation of Government servants from 58 years to 59 years and orders accordingly. This will apply to all those who are in regular service as on date and due to retire on superannuation from 31.05.2020.

- 2. This order shall be applicable to all teaching and non-teaching staff working in aided educational institutions and employees of all Constitutional / Statutory Bodies, Public Sector Undertakings including all State Corporations, Local Bodies, Boards, Commissions, Societies, etc.
- 3. The relevant provisions under rule 56 of Tamil Nadu Fundamental Rules will be modified to the above extent. Necessary amendment to the above rules will be issued accordingly.

ORDER:

In the Government Order first read above, among other economy measures, orders were issued to the effect that there will be a total ban on creation of new posts, with guidelines on creation of new posts in exceptional cases.

- 2. In the Government Order second read above, due to severe financial constraints complete ban on creation of new posts in all Departments had been imposed, and to fill the same by re-deployment for operational purposes.
- 3. Considering, the prevailing situation of COVID 19 in the State and the compelling need to regulate expenditure on emoluments, Government direct that
 - i) there shall be a total ban on creation of new posts in all Departments;
- ii) Recruitment against existing vacant entry level posts including through compassionate ground appointment shall continue, with the approval Staff Committee; and
- iii) Promotions and recruitment by transfer shall continue as per existing procedure.

ORDER:

In the Government Order first read above, orders were issued sanctioning revised rate of Dearness Allowance to State Government employees at the rate of 17 percent with effect from 1st July 2019 following the orders issued by the Government of India and in the Government Order second read above, orders were issued for another ad-hoc increase to employees drawing consolidated pay / fixed pay / Honorarium. In the Government Order third read above, orders were also issued sanctioning revised rate of Dearness Allowance to State Government pensioners/family pensioners at the rate of 17 percent with effect from 1st July 2019 following the orders issued by the Government of India.

- 2. The Government of India, in its Office Memorandum fourth read above, has directed that in view of the crisis arising out of COVID-19, the additional installment of Dearness Allowance payable to Central Government employees and Dearness Relief to Central Government pensioners, due from 1st January 2020 shall not be paid. The additional installments of Dearness Allowance and Dearness Relief due from 1st July 2020 and 1st January 2021 shall also not be paid. However, Dearness Allowance and Dearness Relief at current rates will continue to be paid. As and when the decision to release the future installment of Dearness Allowance and Dearness Relief due from 1st July 2021 is taken by the Government, the rates of Dearness Allowance and Dearness Relief as effective from 1st January 2020, 1st July 2020 and 1st January 2021 will be restored prospectively and will be subsumed in the cumulative revised rate effective from 1st July 2021. No arrears for the period from 1st January 2020 till 30th June 2021 shall be paid.
- 3. The Government of Tamil Nadu has adopted the rate of Dearness Allowance to the State Government employees and Pensioners/Family Pensioners as and when announced by the Government of India to its employees and pensioners/family pensioners.
- 4. Following the orders issued by the Government of India and in view of the severe fiscal crisis arising out of COVID-19 pandemic, the Government has decided to adopt the decision of the Government of India for State Government employees, teachers and Pensioners/Family Pensioners for freezing the Dearness Allowance at current rates till July 2021. The additional installment of Dearness Allowance payable to State Government employees, teachers and Government Pensioners/Family Pensioners, due from 1st January 2020 shall not be paid. The additional installments of Dearness Allowance due from 1st July 2020 and 1st January 2021 shall also not be paid. However, Dearness Allowance at current rates will continue to be paid. As and when the decision to release the future installment of Dearness Allowance due from 1st July 2021 is taken by the Government, the rates of Dearness Allowance as effective from 1st January 2020, 1st July 2020 and 1st January 2021 will be restored prospectively and will be subsumed in the cumulative revised rate



effective from 1st July 2021. No arrears for the period from 1st January 2020 till 30th June 2021 shall be paid.

5. This order shall also apply to the teaching and non-teaching staff working in aided educational institutions, employees under local bodies, employees governed by the University Grants Commission/All India Council for Technical Education scales of pay, the Teachers/Physical Education Directors/Librarians in Government and Aided Polytechnics and Special Diploma Institutions, Village Assistants in Revenue Department, Noon Meal Organisers, Child Welfare Organisers, Anganwadi Workers, Cooks, Helpers, Panchayat Secretaries/Clerks in Village Panchayat under Rural Development and Panchayat Raj Department and other employees drawing pay in the prescribed Level of Pay in the Special Pay Matrix.

ORDER:

In the Government Order first read above, the Government have laid down a transfer policy wherein detailed instructions were issued for making transfer of Government servants in Group A,B and C. In continuation of the above order, the Government have further directed in the reference second read above, that the Government Servants who are having mentally retarded or differently abled children can make a request for his transfer before the completion of 3 years period as mandated in the general transfer policy. The same factor shall also be considered as a valid reason for his retention in the same station up to 5 years.



- 2. The Department of Personnel and Trajning, Government of India in its Office Memorandum third read above, have issued instructions exempting a Government employee who is a caregiver of dependent daughter / son / parents / spouse / brother / sister with Specified Disability, as certified by the certifying authority as a Person with Benchmark Disability as defined under Section 2 (r) of the Rights of Persons with Disabilities Act, 2016 from the routine exercise of transfer / rotational transfer subject to the administrative constraints.
- 3. After careful consideration, the Government direct that a government employee who is a caregiver of dependent daughter / son / parents / spouse / brother / sister with Specified Disability, as certified by the certifying authority as a Person with Benchmark Disability as defined under Section 2 (r) of the Rights of Persons with Disabilities Act, 2016 may be exempted from the routine exercise of transfer subject to the administrative constraints during the transfer period namely, between the 1st April and 31st May, every year. This exemptions is, however subject to the following conditions:-
- (i) A Government servant must be a caregiver of differently abled dependent such as daughter / son / parents / spouse / brother / sister.
- (ii) A Government servant who is a caregiver of differently abled dependent should furnish a certificate, certified by the certifying authority that the dependent is a Person with Benchmark Disability as defined under Section 2(r) of the Rights of Persons with Disabilities Act, 2016.
- 4. The Government also directs to follow the instructions issued in the Government letter second read above while considering the Government Servants who are having mentally ill or differently abled children for transfer.

 - 4. Letter No.16069/BG-I/2020-3, Finance (BG-I) Department, dated 18.06.2020.

Kind attention is invited to the reference third cited, wherein it has been requested to issue suitable further instructions with regard to withholding of general transfers during 2020-21.

- 2. The Government have issued orders / clarification with regard to general transfers during the year 2020-21 as follows:
 - i) General transfers for the year 2020-2021 shall be kept on hold to minimize expenditure on transfer travel expenses;
 - ii) Transfers on administrative grounds and mutual transfers are allowed;
 - iii) Request transfer is also allowed.
- 3. In this connection, it is stated that the general transfers are being effected only during the "transfer period" between the 1st April and the 31st May every year. During the year 2020-21, the general transfer has been kept on hold with a provision to effect transfer on administrative grounds by an authority higher than the authority normally empowered to transfer. However, appropriate authorities have been



allowed to consider mutual transfers & request transfers, subject to the condition that this shall, not pave way for administrative exigencies later.

4. In the light of the clarification issued in the letter fourth cited, it is stated that the request transfer and mutual transfer shall be effected by the transferring authority himself subject to the observance of the conditions issued in this regard by the Finance Department as stated in para 2 above and the Personnel and Administrative Reforms Department in the reference 1st cited. In view of this position, I am directed to state that no further instructions need to be issued in the Personnel and Administrative Reforms Department.

Rules 4 and 9 of the TN GPF Rules read with G.O. first cited provides that the Government Servant, who has joined Government service before 01-04-2003 and is continuously employed would subscribe the minimum amount of 12% of the total of the Basic Pay (i.e) pay drawn in the prescribed level in the pay matrix, Special Pay, Personal Pay, Dearness Allowances to the General Provident Fund upto the last four months of service in respect of persons retiring on attaining the age of superannuation. In the G.O. second cited, orders have been issued extending the age of retirement on superannuation of superior service employees/teachers from 58 years to 59 years.

- 2. In this regard, the Accountant General in his letter cited has pointed out that whether the subscription for the old period is to be recovered in one lumpsum or can be remitted in installments by the subscribers and whether Part Final Withdrawal can be sanctioned to the subscribers who had already drawn 90% of Part Final Withdrawal.
- 3. In this connection, it is clarified that the subscriber shall be allowed the option of paying in one lumpsum or in instalments, any sum not exceeding the maximum amount of arrear subscriptions payable for that period. In respect of sanction of further Part Final Withdrawal, the subscriber shall be allowed for further drawal of Part Final Withdrawal subject to fulfillment of conditions laid down under Rules 15-B of Tamil Nadu GPF Rules and also ensuring the time gap of one year since sanction of 90% Part Final Withdrawal.
